If school fees are outstanding, aftercare may be refused. I understand that there is a late payment charge of R30 if I have not paid my ad hoc care by the 12th of each month or my full time care instalment by the 7th of each month. I agree to give one month's written notice to withdraw my child from aftercare or to pay the fees in lieu thereof.
